UNITED WAY COMMUNITY IMPACT FUND

When you give to United Way of Rhode Island's Community Impact Fund – you help build strong families, support a thriving nonprofit sector, and connect people and organizations to drive lasting change in areas such as affordable housing, quality education, access to workforce opportunities, and essential resources like United Way's 211.

ALLIANCE FOR NONPROFIT IMPACT

Launched in January 2024, the Alliance is a hub for nonprofits across Rhode Island to connect, learn, and grow. It offers practical tools, resources, and professional development opportunities to strengthen nonprofit work statewide. While all nonprofits are welcome, the Alliance places a special focus on supporting organizations led by people of color and smaller, community-based nonprofits.

GOOD NEIGHBOR ENERGY FUND (GNEF)

Since 1989, the Good Neighbor Energy Fund has supported households in Rhode Island who are not eligible for state or federal aid when they face a temporary crisis and cannot meet their energy expenses like their electric or gas bill. The Fund relies on the generosity of Rhode Islanders to help our local neighbors get through tough times.

GEORGE NEED LABOR SOLIDARITY FUND

The newly-launched George Nee Labor Solidarity Fund supports: Union Members & Families, providing emergency relief during times of hardship or strike; Labor-Affiliated Nonprofits with annual mini-grants to organizations that train, protect, and uplift union families; and United Way of Rhode Island's own efforts, such as 211, that connect union households to resources and strengthen solidarity statewide.

WOMEN UNITED

You can join a powerful network of women through United Way of Rhode Island's Women United. You can be among the many Rhode Islanders who give at least \$1,000 annually to United Way's Community Impact Fund and leverage your gift to address disparities. With other Leaders United members, you can come together to learn about the challenges in our community and take action in the solutions.

MY FUND

MyFund (a donor-advised fund) consolidates your giving into one easy-to-access account. Give to the Community Impact Fund, your alma mater, faith organizations, and all of your favorite charities. Make gifts by payroll deduction, credit card, check, securities, or monthly billing. MyFund allows you to give to any 501(c)(3) in the country with a combined annual gift of at least \$1,000.

This pledge represents a contribution for which no goods or services have been received. Gifts made to United Way are tax deductible within the limits of the current law. Any cash contribution received by 12/31 of \$250 or more will receive a tax letter from United Way, per IRS regulations. Letters will be mailed by 1/31. If you have contributed via payroll deduction, you will not receive a tax letter as your pay stub will serve as tax documentation.
